E. Meeting to Consider Duncan Drain 7:10 pm

Moved by Councillor Van Dun Seconded by Councillor Krall That the meeting to consider the Duncan Drain be opened. Carried.

Present: Nick Vanderwal, Floyd Vanderwal and Bob Marriott

Ray Dobbin presented the report noting that the Duncan Drain had been established by a report in 1952. The County of Lambton had replaced the drain during the reconstruction of Petrolia Line. The report confirmed the existing

drainage system as the Duncan Drain complete with catch basins. The report established a maintenance schedule. No work was currently proposed on the drain. Mr. Dobbin noted that the report confirmed the legal right for assessed owners to drain into the Duncan Drain.

Bob Marriott noted that his property did not drain into the Duncan Drain.

Mr. Dobbin noted that he would have his staff revisit the property to check the elevations.

Nick Vanderwal questioned whether the Township was taking over the County drainage system.

Mr. Dobbin noted that municipal drain predated the County drainage system. The report also identified additional properties that were not in existence when the Duncan Drain was established in 1952.

The Clerk reviewed that the Court of Revision notices would be sent to property owners at which time the report assessments could be appealed.

Moved by Councillor McCallum Seconded by Councillor Van Dun That the meeting to consider the Duncan Drain be closed. Carried.

Drainage: Update on municipal drain activities

Ray Dobbin reviewed the status report on drainage work within the Township of Enniskillen.

Court of Revision Kells Drain 7:30 pm

Moved by Councillor Van Dun Seconded by Councillor Krall That the Court of Revision for the Kells Drain be opened. Carried.

Present: Al Langford, Jamie Duncan and Paul Lebert

Ray Dobbin reported that a revised schedule of assessment had been circulated that removed Ken King's property from the drain. He also noted that the revised schedule had corrected the assessment for a culvert on the W1/2 Lot 27.

Jamie Duncan questioned whether the open drain on his farm could be abandoned.

Mr. Dobbin noted that the open portion of the drain could be abandoned on a request from the property owner. He noted that Mr. Duncan would need to install new tile mains to direct the water into the open portion of the Kells Drain. Mr. Langford noted his support for buffer strips to control soil erosion in the open drain.

Moved by Councillor Van Dun Seconded by Councillor Krall

That the revised schedule of assessment for the Kells Drain be approved removing the King property from the schedule and altering the assessment for a culvert on the W ½ Lot 27.

Carried

Moved by Councillor Van Dun Seconded by Councillor McCallum That the Court of Revision for the Kells Drain be closed. Carried.

The Clerk reported that Corey McKinnon had submitted an appeal to the design of the McKinnon Drain report. He had requested that an open swale be installed in branch 1 and that access culverts be installed in branch 2 and 3.

Mr. Dobbin reported that due to the erosion taking place in branch 1 that he could not recommend that the tile be replaced with a swale.

He reported that branch 2 already included an access culvert at the outlet of the branch. He also noted that the report provided the authority to install an access culvert in branch 3. It was noted that during the meeting to consider the report that Mr. McKinnon had indicated that he had installed a low level crossing in Branch 3.

Moved by Councillor McCallum Seconded by Councillor Van Dun That the report for the McKinnon Drain be confirmed. Carried.

Court of Revision McKinnon Drain 7:40 pm

Moved by Councillor Van Dun Seconded by Councillor McCallum That the Court of Revision for the McKinnon Drain be opened. Carried.

No person assessed to the drain was present.

Mr. Dobbin reported that two appeals had been received concerning the drain report.

Chris Sayer reported that he had no benefit from the drainage report. He had no tile drainage from his property entering the McKinnon Drain.

Mr. Dobbin reported that the Sayer property had been resurveyed. He reported that a small portion of the Sayer property should be moved from Branch 1 to Branch 2. He recommended that this would be a change of \$100 to the Sayer property.

Mr. Dobbin read the written appeal received from Corey McKinnon.

Mr. Dobbin reported that none of the existing drains crossing the McKinnon property formed part of a municipal drain. He noted that in his opinion the report as prepared provided sufficient outlet for each of the proposed branches in the drainage report.

Mr. Dobbin reported that he had incorporated the work undertaken by the owner and others into an allowance in Branch 2. He noted that he had used the actual invoice for the work and based on discussions with the contractor removed costs that were not part of the Branch 2 work. This cost was used to establish the allowance provided to Mr. McKinnon on Branch 2.

Mr. Dobbin noted that in this case the provisions of section 32 of the Drainage Act would not apply with respect to allowances.

Mr. Dobbin reported that in branch 1 and 2 access culverts had been proposed. He noted that the report would permit the construction of an access in branch 3 although the costs were not currently included in the report. The maintenance provisions in the report would permit the installation of the culvert in branch 3. The provision of allowances under section 33 of the Drainage Act would not be appropriate.

That a reduction in the assessment be made to the property of Chris Sayer of \$100 and that the assessment be applied to Oil Springs Line.

Carried.

Court of Revision Sarnia Enniskillen Town line Drain 8:00 pm Present: Mark Rainsberry

Mr. Rainsberry noted that he was present to request that the top end of the existing tile drain be flushed to ensure that the roots were removed from the tile. Mr. Rainsberry indicated that he had no concerns with the report assessments.

That the assessment schedule for the Sarnia Enniskillen Town line Drain be confirmed.
