COMMENTS: Lane Closure - County Road 80 (Courtright Line) at Black Creek - Bridge Rehabilitation

- Courtright Line just east of Tile Yard Road in the Township of Enniskillen will be reduced to a single lane for the planned rehabilitation of the bridge crossing at Black Creek.
- The bridge is located approximately 200 metres east of Tile Yard Road.
- The closest 9-1-1 address is 4246 Courtright Line (just east of the bridge).
- Work will be phased such that traffic will be maintained through a single lane and the provision of temporary traffic signals.
- Lane width will be reduced to 3.5 m (11'6") for the duration of the work.
- The bridge rehabilitation is expected to take 12 weeks, weather permitting.
- Commencing Tuesday, May 18, 2021 at 7 am, County Road 80 (Courtright Line) will be reduced to a single lane of traffic at the Black Creek Bridge between Tile Yard Road and County Road 21 (Oil Heritage Road) for a period of 12 weeks, weather permitting.
