A meeting of the Council of the Corporation of the Township of Enniskillen was held on Tuesday October 7<sup>th</sup> 2014 at 7:15 pm at the Enniskillen Council Chambers.

Mayor Marriott chaired the meeting.

## **Pecuniary Interest**

Mayor Marriott requested that each member of Council declare an interest at the appropriate time within the agenda where an interest may exist.

#### A. Minutes

### B. Interview

Planning- Will Nywening:

 Township of Dawn Euphemia Official Plan and Zoning Bylaw public meeting Oct 1 and Oct 8 2014

Mr. Nywening reported that a public meeting would be held on the new official plan and zoning bylaw. He reported on the changes in policy that were being incorporated into the document. He noted the time commitment on the part of Council to undertake the review of the documents.

## 2. Two Dwellings on a Lot

Mr. Nywening noted that a request had been received concerning the construction of a second dwelling unit on a farm property. He reviewed the current provisions of the Planning Act and zoning bylaw.

He was instructed to include this element in the review of the Official Plan in 2015.

### **Public Works**

Water- QMS Audit

The Clerk reported that the QMS audit had been completed and that an update on the plan was underway. The updated plan would be circulated to Council in the future.

Roads- update on salt storage building-The Clerk noted that the door on the new building was still a subject of discussion with the contractor. Once completed the contract would be signed for construction of the building in 2015.

The Clerk reported that the roads department would be purchasing a new laser level as the existing unit was not repairable.

Drainage- Ross White was present to express his dissatisfaction with the construction of the open ditch fronting on a portion of his property. He noted that he would not be able to cut the grass in the new ditch due to the side slopes. He also expressed concern that the side slopes on the drain would erode.

Mayor Marriott noted that a site meeting would be set up on the drain to review Mr. White's concerns.
