SECOND MEETING

MINUTES

JANUARY 20<sup>TH</sup> 2015

A meeting of the Council of the Township of Enniskillen was held on Tuesday January 20<sup>th</sup> 2015 at 7:15 pm at the Enniskillen Council Chambers.

Present: Kevin Marriott, Wally Van Dun, Judy Krall and Kathy O'Hara Wilson

Mayor Marriott chaired the meeting.

## **Pecuniary Interest**

Mayor Marriott requested that each member of Council declare an interest at the appropriate time within the agenda where an interest may exist.

### A. Minutes

Moved by Councillor Krall Seconded by Councillor Van Dun That the minutes of the meeting of January 6<sup>th</sup> 2015 be adopted as circulated. Carried.

#### B. Interview:

Planning: Will Nywening discussion of the timetable to review the Township of Enniskillen Official Plan and Zoning Bylaw.

Mr. Nywening reported that he was preparing documents for the review of the Official Plan and Zoning bylaw.

Mayor Marriott reported that he wanted to have the review take place early in the year. The Clerk was requested to set up two day sessions to be held to review the draft documents during the month of March 2015.

Police: Inspector Scott Janssens- follow up on the OPP policing model Inspector Janssens responded to questions concerning the documents circulated with respect to the new contract pricing. He explained how the data to support the calls for service pricing were generated.

Inspector Janssens noted that the Board had instructed him to provide monthly stat reports to the participating municipalities.

Mayor Marriott questioned the geographic accuracy of the data supplied by the OPP. Inspector Janssens noted that the data was being entered into the computer by civilian staff which he believed would increase accuracy.

Mayor Marriott thanked the Inspector for the presentation.

Roads: Road Superintendent- 2015 road capital program

A review was undertaken of the 2015 budget. The Clerk noted that the general levy had been estimated at \$170,000 higher than in 2014. The Gas Tax revenue and Ontario infrastructure grants were brought into operating revenue for 2015.

The Road Superintendent discussed the 2015 capital budget. He noted that the work included the rebuilding of Tile Yard Road between Rokeby and the Town of Petrolia. Bridges on the Butler Drain and the McKenzie Drains were to be replaced. Also included were the replacement of the Sterling Tandem truck and a pickup.

After discussion Council requested that the replacement of the Sterling Truck be put off for two years and that the rebuilding of Oil Springs Line between Marthaville Road and Tile Yard Road be added to the work for 2015.

Moved by Councillor Van Dun Seconded by Councillor Krall

That the capital budget be amended by the inclusion of the Oil Springs Line project and the replacement of the Sterling truck take place in 2017. Carried.

A discussion took place in regards to changes to the design of the salt shed. The sliding door was replaced with a roll up door. The overhang on the building was extended to 12 inches with the inclusion of ice guards and eave troughs. It was noted that the work would commence on April 17 2015.

Moved by Councillor O'Hara Wilson Seconded by Councillor Van Dun That the salt shed building design be amended:

- 1. by the inclusion of a roll up door
- installation of a 12 inch overhang
- 3. the installation of eave troughs.

Carried.

A discussion took place of additional costs that were not included within the tender. These included the removal of the old salt shed, some site drainage work, installation of electricity to the building, the movement of the fuel storage building and the installation of a fire hydrant.

The Clerk was instructed to return the budget to Council on the first meeting in March 2015.

The Road Superintendent discussed the 2015 gravel tender. He recommended that the use of B gravel be removed from the tender

and replaced with M gravel. He noted that there was sufficient room within the budget estimates to cover off the additional cost.

Moved by Councillor O'Hara Wilson

Seconded by Councillor Van Dun

That the gravel tender be amended to remove the reference to B gravel and it be replaced with M gravel for the Tile Yard Road project.

Carried.

Council discussed the proposed policing contract.

Moved by Councillor O'Hara Wilson

Seconded by Councillor Krall

That the Township of Enniskillen participate in the Lambton Group Policing OPP Contract with the current enhancements.

Carried.
