The report from Will Nywening contained proposed wording changes to Farm Lot Size, the definition of Race Track and Electricity Transmission and Distribution wording in section 3.1.5. All of these changes were in the copy of the Zoning Bylaw that was distributed to Council.

Ray Dobbin said that they were going to brush the whole thing and replace Mr. Vlcek's culvert. Mr. Cascaden asked to have his culvert looked at and repaired, as well. He also would like the tree stump removed out of the culvert.

Councillor McCallum inquired about the removal of trees. Ray Dobbin reported that some trees will need to be removed in the ditch, but not the trees that are up farther in some lawns.

Ray is hoping to begin on the culverts next week.

C. Public meeting Building Bylaw

Mayor Marriott outlined the proposed changes to the Building Bylaw to incorporate Bylaw 59 of 2015 as applicable law under the provisions of the Building Code Act. Bylaw 59 of 2015 required that a fire suppression system be approved by the Fire Chief and installed in all wind turbines constructed within the Township. A building permit would be conditional upon the Fire Chief's approval of the fire suppression system. Section 4.7 (b) of the Building Bylaw requires that a wind turbine developer maintain liability insurance up to \$5 million per occurrence and an amendment has been made to provide that the maximum deductible per claim is \$100,000.00. There are no fee changes being proposed in Building Bylaw.

No comments were made by anyone present.
