MINUTES

FEBRUARY 16 2016

A meeting of the Council of the Corporation of the Township of Enniskillen was held on Tuesday February 16 2016 at 7:00 pm at the Enniskillen Council Chambers.

Mayor Marriott chaired the meeting.

Pecuniary Interest

Mayor Marriott requested that each member of Council declare an interest at the appropriate time within the agenda where an interest may exist.

A. Minutes

B. Interview: Anita Minielly and Richard Poore- Petrolia Community Center 7:10

Ms. Minielly noted that the Petrolia Community Center was celebrating its tenth anniversary. A review was made of the operating budget and the sources or revenue for the Center. She noted that 45% of the participants and employees did not live within the Town of Petrolia.

Ms. Minielly provided an overview of the programming changes taking place at the Center.

Mayor Marriott thanked Ms. Minielly for her presentation.

Roads: Designation of Gas Tax and OCIF projects,

Thames Communication proposal for GPS monitored vehicles

The Road Superintendent recommended to Council that a GPS monitoring system be purchased from Thames Communication. The purchase would require the replacement of the radios in all vehicles and equipment. The radios would permit confirmation of the location of the equipment. He noted it would also indicate when the snow plow equipment was in use.

A discussion took place in regards to the purchase of a repeater to increase the ability to communicate between vehicles.

That the proposal from Thames Communication to purchase a GPS monitoring system for the public works vehicles and equipment be approved. Carried.

The Road Superintendent noted that the license for the repeater would require up to three months to receive.

Drainage: Maintenance Brock Veal Drain

A request for maintenance of the Brock Veal Drain was received from Allan Douglas. Mr. Douglas noted that the tile drain was plugged and required maintenance.

That the Drainage Superintendent be instructed to undertake maintenance work on the Brock Veal Drain.

Water: Review of 2016 water budget

The Clerk reviewed the operating budget for the municipal water system. The Clerk noted that until the MIG Engineering report was completed on the reservoir that it would be difficult to identify additional projects.

1. Review of 2016 Fire budget with long term projected capital expenditures

A review was made of the Township fire capital budget. The projected expenditures had been updated with information from the Petrolia and Inwood Fire Departments. The Clerk reported that with the new expenditure for radios in 2017 there was a need to review the amounts placed in the reserve. A discussion took place in regards to increasing the annual fire surplus to fund the upcoming capital expenditures.

That the 2016 fire rates be increased to provide for a \$70,000 surplus in 2016.

2. Renewal of Park and Reservoir signs

A discussion took place in regards to the replacing the existing park signs. A comparison in pricing was provided to replace the molded lettering with a new display sign.

That the park and reservoir signs be replaced by the purchase of new signs to be placed over the existing display signs.

3. Waste Management Tonnage for Enniskillen 2015

A review was made of the annual tonnage for wastes at the Enniskillen depot at the Petrolia Landfill. It was noted that the tonnage had been reduced by 85 tonnes from 2015.

4. J Kutyba County of Lambton- Closure Petrolia Landfill

An update was provided on the planned closure of the Petrolia Landfill. It was noted that the Enniskillen Depot would remain open after the closure of the site until formal Ministry approval was received.

The closure of the landfill would permit the introduction of reduced hours for the depot.

Council discussed having the depot opened for 18 hours per week. The Clerk reported that information would need to start flowing to the Enniskillen residents in early April as to changes in the hours of operation.

The Clerk reported that Cogeco cable system had requested modifications to 18 streetlights in Oil City. The grounding of the lights were required to meet electricity standards. The Clerk noted that the cost for the work was to be undertaken by Cogeco.
