FEBRUARY 2 2016

A meeting of the Council of the Corporation of the Township of Enniskillen was held on Tuesday February 2 2016 at 7:05 pm at the Enniskillen Council Chambers.

Mayor Marriott chaired the meeting.

Pecuniary Interest

Mayor Marriott requested that each member of Council declare an interest at the appropriate time within the agenda where an interest may exist.

A. Minutes

Moved by Councillor McCallum Seconded by Councillor Van Dun That the minutes of the meeting of January 19 2016 be adopted as circulated. Carried.

B. Interview:

Will Nywening- Enniskillen Pepper- amendment to site plan agreement Mr. Nywening reported that a site plan agreement was in place on the property. He noted that the owners proposed to construct a dwelling unit on the property for seasonal workers. He noted that the site plan required amendment to permit the issuance of a building permit for the structure. He reported that the plan provided landscaping and parking for the new house.

Water: Annual and Summary Report for the Enniskillen Water Distribution system.

Mike Young reviewed the annual and summary reports for the Enniskillen Water Distribution system. He noted that there were no adverse samples generated from the system in 2015. He reported that as a result of the cleaning of the reservoir there was a high turbidity level in one sample.

Mr. Young reported on the amount of water purchased from Petrolia and outlined the calculation for 2015 for a water loss of 9.44%.

Reservoir Report-2015

The Clerk reviewed the financial report for the reservoir with the assistance of Mr. Young and Mrs. Poland. It was noted that there had been higher electricity costs at the reservoir due to electric heating, pumps operating more frequently and higher electricity rates. There were several one-time costs: installation of natural gas heating, replacement of the computer, cleaning of the tanks and replacement of a pressure sensor.

The Clerk was instructed to provide the report to the Oil Springs Council.

G. Other Business

1. Review of 2016 Budget- Street lights, Oil City Sewer

The Clerk reviewed the operating expenses and revenues for the three street lighting systems. It was noted that the increase in electricity costs were equal to the revenue generated for the lighting systems. It was recommended that a review be made again in regards to converting to LED street light systems.

A review of the sewer system had noted that the levy was meeting operating expenses. A discussion took place in regards to the cleaning of the lagoon. Further discussion would take place on both the lighting and sewers in the budget review process.

2. Review of 2016 Insurance Program

The Clerk reported that the insurance program had an increase of 2.5 % in 2016. Part of the increase would be reduced due to the sale of the 2007 GM pickup. A review was made of the broker's proposal to increase coverages. A review was made of the premium savings by increasing the deductible.

A meeting had been set up with the brokers on February 23 2016 to review the program and provide an opportunity for the broker to respond to questions.

3. Canada 150 Community Infrastructure Program- Annex 1

The Clerk was requested to prepare an updated list of usage for the Enniskillen Community Center to be prepared for the March 1st 2016 meeting.

The Clerk reported on the public notice provided for an open house to be held by Union Gas to discuss the construction of a new 48 inch natural gas pipeline to extend from the Dawn Compressor station to Oakdale Road in Enniskillen Township.

A discussion took place concerning the construction of a 120 foot tower at the municipal office to provide for internet service in the area.

That the Council of the Township of Enniskillen supports the construction of a 120 foot guyed tower at the Enniskillen municipal property at 4465 Rokeby Line to be used for the provision of internet service in the area subject to the completion of agreements with TekSavvy. Carried.

Councillor McCallum requested an update on the waste and recycling depot.

The Clerk noted that the Waste Management staff had confirmed continuation of the existing depot pending the approval of a new certificate of approval. The Clerk was requested to discuss staffing of the depot with reduced hours of operation.

Councillor Van Dun reported that a ratepayer had noted that 8-9 beaver dams had been reported in Bear Creek west of the Tile Yard Road bridge. A discussion would take place with the Drainage Superintendent on the matter.
