- A. Presentations were made by three suppliers of cobra style streetlight fixtures for replacement of street lights in Oil City, Marthaville and Howlett Lane.

8:30 am-Des Nell –LED Lighting Solutions- Mr. Nell has supplied street lights for St. Clair Township and the Town of Plympton-Wyoming

9:30 am Tyler Plumb- GE Canada- Mr. Plumb has supplied street lights to the City of Sarnia

10:30 am Arron Averill-Electrozad and Jamie Parsons- Acuity Lighting- has been the successful supplier to the City of Sarnia to supply up to 1,800 street lights.

The Clerk was requested to determine the location of lights in the city of Sarnia installed by Acuity Lighting.
