A meeting of the Council of the Corporation of the Township of Enniskillen was held on Tuesday June 21 2016 at 7:00 pm at the Enniskillen Council Chambers.

# **Pecuniary Interest**

Mayor Marriott requested that each member of Council declare an interest at the appropriate time within the agenda where an interest may exist.

### A. Minutes

Moved by Councillor Krall Seconded by Councillor Van Dun That the minutes of the meeting of June 7 2016 be adopted as circulated. Carried.

# B. Interview

Roads: Tenders surface treatment, Update on Tile Yard Road The Clerk reported that tenders had been received for undertaking surface treatment work on various Township roads.

Oil Springs Line West Nor-John Contracting \$160,263.38 Lloyd's Paving: \$162,545.75 MSO Construction: \$184,127.85

Oil Springs Line East

Lloyd's Paving: \$ 219,274.98 MSO Construction: \$ 228.604.10

The Clerk recommended that the surface treatment tenders be rejected in that two of the contractors had incorrectly tendered the unit pricing on the Oil Springs Line West project and in all cases the work exceeded the budgeted cost for the work. It was recommended that staff be given an opportunity to negotiate a final price for the work proposed for the two sections of work with Lloyd's Paving and MSO Construction.

Moved by Councillor O'Hara Wilson Seconded by Councillor Van Dun That all tenders received for the supply of surface treatment be rejected due to the cost exceeding the budgeted amount;

That Council authorize staff to directly obtain informal quotations from Lloyd's Paving for the Oil Springs Line West project and from MSO Construction for the Oil Springs Line East project with the use of micro surfacing. Carried.

Water: LaSalle Pump/Brooke-Alvinston

The Clerk noted that the Mayor of Brooke-Alvinston has discussed the sale of water with his Council and anticipated a decision at their next meeting.

The Clerk reported on a meeting held with the Ontario Clean Water Agency to discuss the renewal of the contract for water sampling within the municipal system.

The Clerk noted that the water leak repaired north of the reservoir turned out to be a broken farm tile.

Drainage: Request to clean the Kilmer Drain

A request for drainage of the Kilmer Drain was received.

The Clerk reported that a recent Supreme Court of Canada decision had confirmed that the construction of telecommunications towers could not be regulated by municipalities. A brief discussion took place in regards to the Industry Canada process of approval for telecommunications towers.

A discussion took place in regards to the coverage area for wireless internet service. It was noted that Brooke Telecom was expanding a wireless service from the Inwood area which was providing coverage in Enniskillen. Mayor Marriott requested that a meeting be held with TekSavvy to discuss the coverage area of their wireless internet service.

The Clerk noted that a local resident planned to attend a future Council meeting to discuss increased traffic on LaSalle Line.

Councillor Van Dun questioned whether the road grader had been sold. The grader sale had not taken place. A discussion took place in regards to an alternative auction process.

Councillor O'Hara Wilson noted that 35 persons attended the Oil City decoration service. Donations in the amount of \$185.00 were received at the event for use at the Cemetery.

Councillor McCallum requested that the Councillor pay sheets be circulated to Councillors.

Councillor Van Dun questioned the status of the erection of a sign to indicate the entrance to Marthaville Park. The Clerk noted that a directional sign had not be erected at this time.
