TWENTY-FOURTH MEETING

MINUTES

OCTOBER 25 2016

A meeting of the Council of the Corporation of the Township of Enniskillen was held on Tuesday October 25 2016 at 7:00 pm at the Enniskillen Council chambers.

Present: Kevin Marriott, Mary Lynne McCallum, Wally Van Dun, Judy Krall and Kathy O'Hara Wilson.

Mayor Marriott chaired the meeting.

Pecuniary Interest

Mayor Marriott requested that each member of Council declare an interest at the appropriate time within the agenda where an interest may exist.

B. Interviews

Water: LAWSS Correspondence,

The Clerk reported that a meeting of the LAWSS Board was to take place on October 28 2016 with representatives from the Township of Brooke Alvinston to make presentations at the meeting. A memo had been prepared for circulation to the Board regarding the sale of water from Brooke-Alvinston to the Township of Enniskillen. A meeting with the Brooke-Alvinston representatives to review the information was to take place on October 27 2016.

OCWA water sampling agreement,

The Clerk reviewed the water sampling agreement with the Ontario Clean Water Agency. The agreement would extend the term for an additional three years. The Clerk noted that that Village of Oil Springs had indicated that they would no longer take part in the agreement. The Clerk noted that the cost provided by OCWA was still lower than the work being undertaken by Enniskillen.

CWWF Program memo and resolution

The Clerk reported that the Village of Oil Springs had agreed to participate in an application for the CWWF program which would involve upgrades to the reservoir. Each municipality would commit their funding allocation under the program to provide for a maximum expenditure of \$200,000. The proposed work would permit the replacement of three pumps, the variable speed drives, electronic operating system and backup generator.

The Clerk noted that MIG Engineering had been requested to prepare an estimate for the engineering for the project. Their proposal would be available for the next regular meeting.

That the Council of the Corporation of the Township of Enniskillen directs that a joint application be submitted to the Clean Water and Wastewater Fund (CWWF) with the Corporation of the Village of Oil Springs to support the rehabilitation of the Oil City/Oil Springs Reservoir:

That the joint project be named the Oil City/Oil Springs Reservoir Upgrade;

That the estimated cost of the joint project is \$200,000 which consists of;

- 1. the maximum Federal allocation to the Enniskillen share of the project is \$50,000;
- 2. the maximum Ontario allocation to the Enniskillen share of the project is \$25,000:
- 3. the Township of Enniskillen allocation to the project is \$25,000;
- 4. the Village of Oil Springs allocation to the project is \$100,000. Carried.

Roads: Update on Oil Springs Line surfacing- The Road Superintendent reported that the asphalt suppliers had not attended Oil Springs Line to complete the work.

Grader Replacement-

The Road superintendent noted that the bill for the Road Grader had not been paid as several attachments had not been installed on the new unit. Toromont sales had not responded to requests for completion of the work. It was noted that payments would be withheld until the tendered parts were supplied.

The Road Superintendent was asked to setup a photo op for the grader on November 7 2016 at I pm.

Update on Pavement Condition Index- The Road Superintendent reported that he would be starting the pavement condition inspection in the next week.

Mike Cumming reported that the installation of the new chlorinator at the reservoir would take place once the technician attended the site. He reported that several water services were being repaired. Otherwise locates were taking up a lot of time.
