SEPTEMBER 6 2016

A meeting of the Council of the Corporation of the Township of Enniskillen was held on Tuesday September 6 2016 at 7:10 pm at the Enniskillen Council Chambers.

Mayor Marriott chaired the meeting.

Pecuniary Interest

Mayor Marriott requested that each member of Council declare an interest at the appropriate time within the agenda where an interest may exist.

A. Minutes

Moved by Councillor Krall Seconded by Councillor O'Hara Wilson That the minutes of the meeting of August 23 2016 be adopted as circulated. Carried.

B. Public Meeting

1. Application by Racher Farms Ltd for rezoning of Con 7 West ½ Lot 11 to prohibit a dwelling on the farm.

Present: Greg and Debra Racher

Will Nywening reported that the zoning of the farm property to prohibit the construction of a future dwelling unit was required as a condition to a severance approval to separate the farm dwelling at 4012 Shiloh Line. Mr. Nywening reported that a minor variance had been approved in regards to the MDS. The zoning bylaw would not affect the dwelling lot or the woodlot on the property. Mr. Nywening reported that the actual size to the approved lot was 3 acres.

No comments were made regarding the application.

Moved by Councillor McCallum Seconded by Councillor Van Dun That the application for rezoning by Racher Farms for the West ½ Lot 11 of Concession 7 be supported. Carried. 2. Application by Bruce Cox for rezoning of Con 12 East ½ Lot 27 to prohibit a dwelling on the farm land, allow a reduction is MDS setbacks from livestock facilities at 5619 and 5726 LaSalle Line and recognize 3550 square feet in detached accessory building lot coverage.

Mr. Nywening reported that he had provided those present an overview of the report on the application during the severance application review.

No comments were made on the rezoning application.

Eileen Williams: Request to reduce the speed limit on Oil Heritage Road in Oil City 7:30 pm

The Clerk reported that Mrs. Williams had requested to attend the meeting of September 27 2016 to present a petition on reducing the speed limit on County Road 21 in Oil City.

Roads: 2017 County of Lambton- salt pricing, update on radio installations, Update on Oil Springs Line surface treatment, update on Grader delivery

The Road Superintendent reported that Sifto Salt was willing to maintain salt prices for the 2016-17 winter season at \$69.74 per tonne.

That the Township of Enniskillen continue to purchase road salt under the County of Lambton purchasing contract for the 2016-17 winter season. Carried.

The Road Superintendent reported that Thames Communication was still attempting to obtain spectrum allocation for the new repeater for the public works radio system.

The Road Superintendent noted that the surface treatment had been placed on Oil Springs Line between Marthaville Road and Tile yard Road. One road patch remained on Shiloh Line.

The Road Superintendent reported that he would obtain pricing for asphalt patching to remove an issue of ponding on Oil Springs Line east of Oil Springs.

Water: Update on Lead sampling

Mr. Cumming reported that the second round of lead sampling had been completed with no issues arising.

Mr. Cumming reported on water repairs undertaken in the distribution system.

Remedial Plans for the Sydenham Water Shed

Sewer: Update on sewage lagoon

Contact had been made with OCWA to place alum in the lagoon during the month of October.

Sampling would be undertaken of the amount of sediment in the lagoon prior to the discharge of the lagoon.
