EIGHTH MEETING MINUTES APRIL 18 2017

A meeting of the Council of the Corporation of the Township of Enniskillen was held on Tuesday April 18 2017 at 7:10 pm. at the Enniskillen Council Chambers.

Present: Kevin Marriott, Mary Lynne McCallum, Wally Van Dun, Judy Krall and Kathy O'Hara Wilson

Mayor Marriott chaired the meeting.

Pecuniary Interest

Mayor Marriott requested that each member of Council declare an interest at the appropriate time within the agenda where an interest may exist.

A. Minutes

Moved by Councillor Krall Seconded by Councillor O'Hara Wilson That the minutes of the meeting of April 4 2017 be adopted as circulated. Carried.

B. Interviews:

Planning- Will Nywening- Residential land Supply and Draft Official Plan Mr. Nywening reported that the County Council had recommended that the residential land supply report be forwarded to each municipality in the County for comments. Mr. Nywening reviewed the method used to determine the amount of vacant land available in each of the County municipalities. He reported that on average 7 new residential units were constructed in Enniskillen annually. He reported that the inventory is likely larger due to the vacant farm properties.

Fred Sterling noted that the County Official Plan projected a decline in population. He asked why additional residential land was required in the County. Mr. Nywening reported that the number of people per house was declining. Mr. Sterling noted that it would be a shame to see the farm land in Plympton-Wyoming used for residential purposes.

Drainage: Tenders Durham Creek, 8th Concession Drain and 12 Concession Drain.

Ray Dobbin reported that tenders had been opened on the Durham Creek, 8th Concession and 12 Concession Drain.

Moved by Councillor O'Hara Wilson Seconded by Councillor Krall That the following low tenders be accepted: 8th Concession Drain- McNally Excavation \$ 142,282.11

12TH Concession Drain- McNally Excavation \$ 17,786.20 Durham Creek Drain- J&L Henderson \$ 50,199.12 Carried.

Site Meeting Wagner Drain:

Ray Dobbin reported on the site meeting concerning the Wagner Drain. He noted that the existing report provided the authority to install a new culvert for Mr. Douglas on the Wagner Drain.

Moved by Councillor Van Dun

Seconded by Councillor McCallum

That the Drainage Superintendent proceed to replace the Douglas culvert on the Wagner Drain.

That a 300 foot portion of the Wagner Drain be cleaned. Carried.

Discussion of Whiting Drain Report

The Engineer reported to Council on the installation of buffer strips on the Whiting Drain. The vegetative strips would reduce the soil erosion. He noted that the report provided allowances to the landowners where the buffer strips were to be installed.

A discussion took place in regards to the maintenance of the buffer strips. It was recommended that the representative of the company planting the strips be present to explain what type of vegetation was being planted and how to maintain the vegetation.

Moved by Councillor O'Hara Wilson Seconded by Councillor Van Dun That the Whiting Drain report be circulated. Carried.

Councillor Krall requested that the Drainage Superintendent contact Jim Krall regarding the placement of dirt on the driveway access.

The Drainage Superintendent noted that work on the Brock-Veal Drain would start next week.

Councillor O'Hara Wilson requested information on the availability of headwall blocks for the culvert projects for the current year.

The Drainage Superintendent noted that he did not anticipate an issue with the availability of blocks although the cost was increasing.

Roads: Update on: Grader Sale

The Clerk reported that the 2005 Volvo road grader had been sold.

Water: Update on Reservoir Project,

The Clerk reported that reservoir tenders were due on Thursday April 20 2017.
