MINUTES

APRIL 4TH 2017

A meeting of the Council of the Corporation of the Township of Enniskillen was held on Tuesday April 4th 2017 at 7:00 p.m. at the Enniskillen Council Chambers.

Mayor Marriott chaired the meeting.

Pecuniary Interest

Mayor Marriott requested that each member of Council declare an interest at the appropriate time within the agenda where an interest may exist.

A. Minutes

Moved by Councillor O'Hara Wilson Seconded by Councillor Krall That the minutes of the meeting of March 21 2017 be adopted as circulated. Carried.

B. Interviews

Water: Enniskillen Township Water Distribution inspection report,
Mike Cumming reviewed the Ministry Environment inspection report of the
water distribution system for 2016. He noted that the Ministry inspector had
outlined three deficiencies that had been addressed.

Water System summary report 2016- Mike Cumming reviewed the water system summary report that outlined the amount of water received from Petrolia and the amount of water pumped from the reservoir. The report listed the repairs to the water main and services.

Moved by Councillor Van Dun Seconded by Councillor McCallum That the 2016 Water System Summary Report be accepted. Carried.

Update on Reservoir Renovations- The Clerk reported that tenders had been advertised for the renovation of the reservoir. A bidder's site meeting was planned for April 6 2017. Tenders were due on April 20 2017.

The Clerk reported that a meeting had been held with the administrative staff at Dawn-Euphemia to provide an update on their request for additional water to supply a greenhouse proposed for their Township. Roads: Update on- Gravel Delivery, Shop Crane, Volvo Grader

The Road Superintendent reported that he anticipated that stone for stock pile in the yard would start in the current week. He noted that the roads were too soft to apply gravel.

The Road Superintendent reported that he could only find one contractor to repair the shop crane. He noted that the repairs would have to be undertaken shortly as the crane was required to remove snow plow equipment from the trucks.

A discussion took place in regards to the sale of the 2005 Volvo Grader. The listing on the web site Govdeals had been taken down. The grader had been advertised on Kijji and a bid had been received of \$48,000.

Councillor Van Dun noted that many people in the community were comfortable with electronic bill paying. Councillor McCallum noted that there would be an increase cost in the process. A discussion took place in regards to the financial viability of the company providing the service. The Clerk noted that the review undertaken of the financial capability of the company had not found a concern. A concern was brought forward in regards to the security of the process.

The Clerk noted that a bylaw to adopt the alternative method would need to be approved prior to May 1 2017.

The Clerk noted that due to the increasing numbers of false alarms for carbon monoxide and smoke alarms that a request had been made to the Chief Building Official to report on the alarm systems. The Chief building Official confirmed that the life expectancy for the units was 7-10 years. People were not familiar with the sound made by the devices when they failed.

A discussion took place in regards to the consolidation of the Inwood Fire area into the Oil Springs fire service area.
