SIXTH MEETING

MINUTES

MARCH 13 2018

A meeting of the Council of the Township of Enniskillen was held on Tuesday March 13 2018 at 7:10 pm at the Enniskillen Council chambers.

Present: Kevin Marriott, Mary Lynne McCallum, Wally Van Dun, Judy Krall and Kathy O'Hara Wilson.

Mayor Marriott chaired the meeting.

Pecuniary Interest

Mayor Marriott requested that each member of Council declare an interest at the appropriate time within the agenda where an interest may exist.

A. Minutes

Minutes of the meeting of February 28 2018

The Clerk noted that the minutes would be circulated for the next meeting.

B. Interviews

1. Will Nywening- Housekeeping amendments

Will Nywening reported that the recent housekeeping bylaw approved by Council did not contain the most recent recommendations for regulating shipping containers. He discussed the options available to Council to address the matter.

Mr. Nywening reported that Council could incorporate regulations dealing with the sale of cannabis.

Moved by Councillor McCallum

Seconded by Councillor Krall

That the shipping container regulations be incorporated in future amendments to the zoning bylaw.

Carried.

2. Oil Springs/ Review of Reservoir 7:30 pm

Larry Wagner and Erkki Pohjolainen were present from the Village of Oil Springs. It was noted that questions received from the Village concerning the reservoir operation had been circulated for review. Larry Wagner indicated that the Township water loss was high and asked what could be done to address the matter. A discussion took place regarding meter replacement policy.

The Clerk provided an update on the replacement of the SCADA system, pumps and variable speed drives at the reservoir. It was noted that the project should be completed by the end of April 2018.

3. Roads: Update on Roads-verbal

The Road Superintendent reported that he was awaiting the visit of a contractor to review asphalt pricing.

He reported that the delivery instructions had been requested for the new tandem truck although a delivery date had not been provided.

Councillor O'Hara Wilson questioned about the condition of a culvert on Tile Yard Road south of Courtright Line. The Road Superintendent noted that the small culvert had collapsed and the crossing filled in with gravel.

4. Water: 2018 Water Budget

A review was made of the 2018 water budget. The new capital items were discussed.

5. Drainage: McKinnon Drain update

The Clerk reported that the decision of the Court of Revision had been appealed by a ratepayer to the Drainage Tribunal.

A drain maintenance request had been received for the Bradley Drain. The Drainage Superintendent had reported that he wanted to proceed to hire a contractor on an hourly basis to compete the clean out of a portion of the drain.

That the Drainage Superintendent proceed to clean out a small section of the Bradley Drain on the West half lot 1 Concession 12. Carried.

A request for drain maintenance had been received for the Strangway Bridges Drain.

That a site meeting be set up for the Strangway Bridges Drain with Councillor O'Hara Wilson as the Council representative.

Carried.

6. Sewer: Update on pump replacement

Mike Cumming reported that pump 2 at the sewer pump station had been removed and replaced with the backup pump. He noted that the pump had

been damaged by a chain. Discussions were underway to price a new replacement pump.

A discussion took place in regards to hosting a road tour for Council on April 12 2018.
