The Clerk reported that a revised agreement defining the response area of the Oil Springs Fire Department had been forwarded to the Village for review. The amendment was to address the inclusion of the Inwood fire area into the Oil Springs Fire area.

TWENTY-SECOND MEETING

4 NOVEMBER 13 2018

Councillor Van Dun and Mayor Marriott discussed a meeting with the Waste Management representatives at the Petrolia landfill to discuss the future layout of the depot.

It was noted that Waste Management would prepare a site plan of the site. The site plan would locate the fencing, gates and the positioning of the dumpsters. A discussion had taken place regarding the installation of electricity to an office trailer to be used by the monitors. The discussion had also taken place regarding lighting at the site. With the removal of most of the onsite lights it was suggested that the hours of operation be changed to day light hours only.

There was also discussion of drainage along the roadway to the depot.

A. Meeting to Consider the McCrie Drain Report 7:30 pm

Moved by Councillor Van Dun Seconded by Councillor McCallum That the meeting to consider the McCrie Drain be opened. Carried.

Present: Jake Feenstra

Ray Dobbin indicated that the report provided for a new schedule of assessment for maintenance of the drain. The report expanded the drainage area to reflect the drainage area for the Strangway-Bridges Drain. The report made provisions for the replacement of culverts on the drain.

Moved by Councillor O'Hara Wilson Seconded by Councillor Krall That first and second reading be given to Bylaw 79 of 2018 a bylaw to adopt the McCrie Drain Report. Carried.

Ray Dobbin proceeded to update Council on the maintenance projects underway and the status of new reports.

B. Meeting to Consider the Willow Swamp Drain Report 7:45 pm

Moved by Councillor Krall Seconded by Councillor O'Hara Wilson That the meeting to consider the Willow Swamp Drain report be opened. Carried.

Present: Jim Blackman and Matt Samko

The Engineer reviewed the new report for the drain. He reviewed the Willow Swamp Drain which included a 400 mm tile drain that had been replaced in a 1974 report. He proposed to install a new catch basin on the north side of Oil Springs Line that would have a flap gate. The gate would be installed to prevent water from backing up into the tile system. Secondly a flap gate would be installed on the road culvert to prevent water from Black Creek from flowing under the road to the south.

The report included a construction and maintenance schedule.

A discussion took place concerning the future removal of debris from the catch basin and the flap gate on the culvert. Mr. Blackman was made clearly aware of the need for regular inspection of the gates to ensure that debris was removed.

Matt Samko noted that he farmed property on the north side of the road east of the proposed catchbasin. He requested that a knockout be installed in the catchbasin to permit a tile to be installed in the catchbasin. A discussion took place in regards to the elevation of the catch basin to permit tile connection. The Engineer noted that there was a limit on how low the catchbasin could be installed to permit water to flow into Black Creek.

Jim Blackman discussed the installation of road access culvert to permit access to his property from Oil Springs Line.

It was noted that this was a matter to be discussed with the Road Superintendent.

Ray Dobbin noted that a revised schedule of assessment would be circulated to the Court of Revision. The assessment of an upstream land owner would be amended to recognize additional tiled land into the Naylor Piggott Drain.

Moved by Councillor McCallum Seconded by Councillor Van Dun

That first and second reading be given to Bylaw 80 of 2018 a bylaw to adopt the Willow Swamp Drain Report.

Carried.

Mr. Dobbin completed his update on the status of drain maintenance. He reported on his attendance at a meeting to discuss phragmites control. Mr. Dobbin anticipated a County committee to be established to continue the control of phragmites in the County.

In responding to Council questions Mr. Dobbin indicated that there had been some improvement by Contractors notifying farmers prior to starting work on projects.

Mr. Dobbin noted that he would communicate again with the Nativescape group to discuss obtaining an invoice for the work on the McKinnon Drain.
