ELEVENTH MEETING

MINUTES

JUNE 4 2019

A meeting of the Council of the Corporation of the Township of Enniskillen was held on Tuesday June 4 2019 at 7:00 pm at the Enniskillen Council Chambers.

Present: Kevin Marriott, Mary Lynne McCallum, Wally Van Dun, Judy Krall and Chad Burke

Kevin Marriott chaired the meeting

Pecuniary Interest

Mayor Marriott requested that each member of Council declare an interest at the appropriate time within the agenda where an interest may exist.

A. Minutes

Moved by Councillor Krall Seconded by Councillor Burke That the minutes of the meeting of May 21 2019 be adopted as circulated. Carried.

B. Interviews

1. Roads: Update on Rokeby Line

The Road Superintendent noted that the representative from Norjohn had not visited the Township to review the work undertaken on Rokeby Line west of Oil Heritage Road. He reported that he planned to replace culverts in Rokeby Line between Wanstead Road and Forest Road prior to the placement of asphalt on the road.

The Road Superintendent reported that the maintenance gravel had been completed on May 31 2019.

He reported that the placement of brine on the gravel roads would start in the next week.

The new road side mower was received this date. The new single axle dump truck had been ordered.

Work was currently underway on the Caroline Street Drain.

Water: Petrolia Water Treatment Plant-Clear well and HLP project update, Water Pressure Event May 28 2019

A brief update was received from the Town of Petrolia regarding the work being undertaken at the water treatment plant in Brights Grove.

A review was undertaken regarding a pressure drop in the municipal water system. It was noted that a pump at Petrolia's Mandaumin pumping station had stopped pumping water to the Petrolia water tower. This was not noticed until the pressure started to drop in the Enniskillen distribution system and the Petrolia distribution system. The event had been reported to the Ministry of Environment, Public Health and the Spills Action Line. The water sampling results requested by Public Health did not provide any indication of water quality issues in the Enniskillen distribution system.

3. Drainage: Stewart Drain Site Meeting, Drainage Superintendent Report

Ray Dobbin provided an update on the Stewart Drain site meeting. Four ratepayers attended the meeting. They requested that option 1 in the preliminary report be approved for work on the drain.

That the Engineer be directed to proceed to prepare a final report on the
Stewart Drain using option 1.
Carried.

Mr. Dobbin reviewed his updated status report on municipal drainage work in the Township.

C. Meeting to Consider- 6 Sideroad Drain Extension 7:30 pm

Present: Wayne Anderson. Dave Henderson, Brian Anderson

Moved by Councillor Van Dun Seconded by Councillor McCallum That the meeting to consider the 6 Sideroad Drain report be opened. Carried.

Mr. Dobbin reviewed the report outlining the work to be undertaken to extend the 6 Sideroad Drain from the driveway of Brian Anderson to the outlet of the Murphy Drain. He noted that obstructions in the open ditch would be removed, the water course straightened and erosion control materials installed where required.

Mr. Dobbin reported that in discussions with Mr. Anderson it was agreed to remove the special assessment to his property as the additional erosion control was not required on his property.

Mr. Dobbin reported that he had been contacted by Keith Woods who had indicated that the drainage area for his property was incorrect.

Brian Anderson expressed concern that he was over assessed to the drain as most of his water drained in another direction into Black Creek. He indicated that most of the water was coming from the upper areas of the drain.

The Engineer reported that he would meet with Mr. Anderson to discuss his drainage area. If he agreed with the changes he would revise the schedule of assessment on the drain to reflect the altered drainage area.

Dave Henderson questioned who had asked for the work.

Councillor McCallum questioned whether the report provided for maintenance provisions for culvert replacement in the future when required. The Engineer confirmed that culvert replacement was addressed in the report.

Moved by Councillor Krall Seconded by Councillor Burke That first and second reading be given to Bylaw 35 of 2019 - 6th Sideroad Drain Extension Report. Carried.

A discussion took place in regards to the Court of Revision which would take place during the month of July 2019.

Tenders were circulated for maintenance of the Dennis Robertson Drain and the Plympton McLauchlin Drain.
