SIXTEENTH MEETING

MINUTES

AUGUST 20 2019

A meeting of the Council of the Township of Enniskillen was held on Tuesday August 20 2019 at 7:10 pm at the Enniskillen Council Chambers.

Present: Kevin Marriott, Mary Lynne McCallum, Wally Van Dun, Judy Krall and Chad Burke

Mayor Marriott chaired the meeting.

Pecuniary Interest

Mayor Marriott requested that each member of Council declare an interest at the appropriate time within the agenda where an interest may exist.

A. Minutes

Moved by Councillor Krall

Seconded by Councillor Van Dun

That the minutes of the meeting of August 6 2019 be adopted as circulated. Carried.

B. Interviews:

Planning- Update on OPA # 1 and # 2

Rob Nesbitt noted that the County Planning approval officer had approved Official Plan amendments 1 and 2. The approvals had been delayed due to the delay in the approval of the County of Lambton Official Plan. He reported that the amendments to the Township Official Plans were still subject to appeal. Mr. Nesbitt reviewed both Official Plans outlining the general contents.

Councillor Krall questioned whether the Township had the authority to apply a set-back for growing cannabis in open fields. The Planner was requested to prepare a report on the matter.

The Planner reported that applications had been received from High Park for the manufacturing of cannabis edibles from within the existing greenhouse on LaSalle Line. Mr. Nesbitt noted that he would be preparing planning reports for Council consideration for a public meeting to be held in September.

Roads – Update on road shouldering

The Clerk reported that the shouldering of Rokeby Line in the areas of the new asphalt was completed. The Roads Department was placing gravel at the road intersections and driveways.

The Clerk reported that a culvert on South Plank Road south of Black Creek Golf Course was failing. Locates had been called to replace the culvert.

The Clerk reported that site meetings had been held on the 13th Concession Drain and the 14th Concession Drain. The land affected on both drains was outside of the area covered under the most recent reports.

Replacement culverts were required on both drains.

That Ray Dobbin Engineering Inc. be appointed to prepare a new report under Section 78 of the Drainage Act for the 13th Concession Drain and the 14th Concession Drain to address the replacement of culverts. Carried.

A discussion took place regarding private work undertaken by property owners on the Richards Drain. Work had been undertaken without municipal approval.

That a meeting of the ratepayers on the Richards Drain be held at the next Council meeting.

1. Memo Ministry of Environment compliance practices

The Clerk reviewed notice of a change in the Ministry of Environment practices regarding complaints in commercial and industrial facilities. The policy change would permit the Ministry in localized events to leave municipalities to address complaints.

2. SWIFT RFP process update

Mayor Marriott discussed a recent meeting with a representative from Cogeco regarding general plans of the company to be involved in the SWIFT RFP. The Clerk noted that the RFP would close on October 4 2019 and results would be determined by late October 2019.

The Clerk reviewed announcements made at the Association of Municipalities of Ontario conference by the Premier. The Premier had noted that the OMPF program would remain unchanged for 2020.

The Premier and Minister of Health both noted that the funding of Health Units would be reduced in 2020. They noted that the maximum increase in cost to the municipalities affected would be 10%. The province would provide contingency funding to guarantee this maximum threshold.

The Minister of Natural Resources issued a notice to Conservation Authorities directing that they limit their programs to the recognized core activities.

H. In camera meeting will be held under section 239 (c) of the Municipal Act to discuss the sale of the Enniskillen Community Center lot in Oil City.
