ELEVENTH MEETING

MINUTES

JUNE 7 2021

An in-camera meeting of the Council of the Township of Enniskillen was held on Monday June 7 2021 at 6:30 p.m. electronically through Zoom Teleconference. The in-camera meeting was held under the provisions of the Municipal Act (1) Section 239 (2) (h) to discuss information supplied in confidence by the Governments of Ontario and Canada.

The regular meeting of the Council of the Township of Enniskillen was held on June 7 2021 at 7:00 pm with access to the public to electronically join or view the meeting through a Zoom Teleconference format. Mayor Marriott chaired the meeting,

Pecuniary Interest

Mayor Marriott requested that each member of Council declare an interest at the appropriate time within the agenda where an interest may exist.

A. Minutes

Moved by Councillor Krall Seconded by Councillor Burke That the minutes of the meeting of May 17 2021 be adopted as circulated. Carried.

B. Interviews

Trevor Brand: Questions regarding the future use of the High Park Farms Facility Trevor Brand asked which site plan affected the High Park Farms facility. He questioned whether the site plan could be revoked. Councillor McCallum noted that the matter would be discussed in the future.

Trevor Brand questioned whether the interim control bylaw affecting cannabis operations would limit the property currently operated by High Park Farms. Trevor Brand questioned about the duration of the Interim Control Bylaw. Trevor Brand noted that the light issue associated with greenhouses would be addressed on July 12 2021 with the Town of Leamington.

Trevor Brand noted that his understanding of the provincial policy statements indicated that the growing of cannabis did not fit as a permitted use in agricultural areas.

Trevor Brand noted that his neighbours had expressed concerns about the speed and volume of traffic on LaSalle Line.

Councillor Krall noted that she had been in discussions with Greg Racher of Racher Farms concerning the residential development of land in the Town of Petrolia affecting his property at Marthaville Road and Discovery Line.

Mr. Nesbitt reported that he was aware that some discussions had taken place between a developer and the representatives of Racher Farms.

Drains: Kells Drain chronology,

Mayor Marriott noted that there is a need to ensure that once a contractor has completed work on a drain that they are required to return for clean up of the site. The Clerk noted that the work on the specific bridge was undertaken on an hourly basis. The cost of remediation was an additional charge to the drain.

Councillor Van Dun noted that the appearance of the cement headwalls in Enniskillen did not appear to be constructed to the same standard as in Chatham Kent. He recommended that a meeting be held with contractors to discuss the matter.

It was noted that insufficient supervision of contractor work was taking place on drain projects.
