Sewers- Update on pumping station test

The Clerk reported that the cleaning of the Oil City Sewer force main had taken place the week of August 9 2021. The draw down test of the sewer pump station was completed and a report to be submitted within the next two weeks regarding the capacity of the pump station.

The Clerk provided an update on the Environmental Assessment project regarding Rokeby Line at Bear Creek. He noted that BM Ross Associates had circulated a copy of the geotechnical report. The assessment of the natural features would be completed in September. The Clerk noted that the consultant would be preparing an option report with estimated costing in the early fall.

The Clerk reported that the cab and chassis for the new tandem truck had been delivered to Viking Cives on August 11 2021. The Road Superintendent requested that the sale of the old truck should be put on hold until a firm delivery date was received from the supplier.

It was noted that both Oil Springs and Dawn-Euphemia had confirmed participation in the project.
