MINUTES

JULY 18TH 2022

The regular meeting of the Council of the Township of Enniskillen was held on Monday July 18th 2022 at 7:00 pm with access to the public to electronically join or view the meeting through a Zoom Teleconference format. Information was available on the municipal website to gain access to the meeting. (www.enniskillen.ca)

Mayor Marriott chaired the meeting

Pecuniary Interest

Mayor Marriott requested that each member of Council declare an interest at the appropriate time within the agenda where an interest may exist.

A. Minutes

Moved by Councillor Krall Seconded by Councillor Burke That the minutes of the meeting of July 4 2022 be adopted as circulated. Carried.

B. Interviews

Drains- Minutes Court of Revision- Gurd Drain, Tender results Gurd Drain,

Councillor Krall reported that no persons had submitted appeals to the Gurd Drain Court of Revision held by the Village of Oil Springs. Tenders were opened for the work and GM Construction was awarded the work at a price of \$28,537.58.

East Napper Drain site meetings

Councillor Krall reported on the site meeting held for the East Napper Drain. Councillor Krall reported that there was an interest on the part of the property owners to have the work completed at the present time while GM Construction was cleaning the Perkins Drain.

Councillor Krall reported that there was substantially more brushing required on the drain in comparison to the Perkins Drain.

The Drainage Superintendent reported that he had received an estimate for the work from GM Construction. GM Construction had agreed to complete the work following completion of the Perkins Drain at an estimated cost of \$26,800.

That GM Construction be authorized to brush and clean the East Napper Drain at an estimated cost of \$26,800.

Roads: Fox Creek Bridge Shiloh Line,

The Clerk reported that the contractor had started work on the deck repairs to the bridge. The asphalt had been removed from the deck and parts of the cement deck were under repair.

A discussion took place regarding the placement of brine on Gypsie Flats Road. The Clerk noted that the road would be graded prior to the application of brine.

Community Safety Zone Signs,

The Clerk reported that signs had been installed on Marthaville Road between Petrolia Line and LaSalle Line. The Clerk noted that the police were actively patrolling the area.

Marthaville Road resurfacing

The Clerk noted that Huron Construction had not provided a start date for the work on Marthaville Road.

Sewer: Lagoon sludge depth tests,

The Clerk noted that the sludge depth tests for the Oil City Sewer lagoon had taken place. The results had yet to be received from OCWA.

Draft Ministry operating certificate of approval

The Clerk reported that the draft operating certificate of approval for the collection system for the Oil City Lagoon was currently being reviewed by staff.

Water: Update on activities

The Clerk provided a brief update on water department activities.

The Clerk reported that a petition had been received for a new municipal drain from Rick and Wendy O'Hara for property located at Lot 31 Concession 12. The work would consist of a road bore to place a tile under Forest Road to provide outlet for the farm drainage tile.
