The regular meeting of the Council of the Township of Enniskillen was held on Monday September 19th 2022 at 7:00 pm at the Enniskillen Council Chambers.

Kevin Marriott chaired the meeting.

Pecuniary Interest

Mayor Marriott requested that each member of Council declare an interest at the appropriate time within the agenda where an interest may exist.

A request was received from the owner of 5092 Courtright Line to replace the culverts on the property which formed part of the 4th Concession Drain.

Councillor Krall noted that the clean up of the Oil City Cemetery was planned for the near future.

Mrs. Poland noted that an emergency exercise would be planned to take place in the next three months.

The Clerk noted that Councillor training was being planned after the new Council term started. The Clerk noted that information would be circulated to Council regarding the training.
