Ray Dobbin reported that a revised schedule of assessment had been circulated that abandoned the second access culvert for the Dawn Vaskor property.

Ray Dobbin reported that no written or verbal appeals had been received regarding the assessments in the Simpson Drain report.

The Clerk confirmed that no written or verbal appeals had been received regarding the assessments in the Simpson Drain Report.

Carl Martin noted that he had been assessed for benefit in the report. He questioned why he should have a benefit assessment since he did not have a culvert to be replaced in the report.

Ray Dobbin noted that he would speak to Carl Martin regarding the assessment.

Ross White and Eugene Levasseur discussed the overall cost of the work and made recommendations to change the method of design and tendering to achieve a lowering of the cost to the ratepayers on the drain. Ross White recommended incorporating the purchasing practices used in the plants to achieve lower costs.

A discussion took place regarding the Planning Act changes that would permit up to three dwelling units on a residential property. Mr. Melanson noted that the no clear policy had been developed addressing additional units in areas served by septic systems.
