Pecuniary Interest

1. Memo 2024 Budget- Grants

The Clerk circulated a report on grants provided in 2023 and additional requests for 2024.

Moved by Councillor McCallum Seconded by Councillor Van Dun That a donation of \$500 be made to the St Clair Region Conservation Authority in 2024 to assist in tree planting. Carried.

Moved by Councillor Van Dun Seconded by Councillor Krall That a \$200 grant be made in 2024 to the Lambton Plowmen's Association. Carried.

Moved by Councillor Van Dun Seconded by Councillor Burke That the annual budget for grants be set at \$27,500 for 2024. Carried.

Councillor Krall declared a conflict of interest as she is a director on the Petrolia Enniskillen Agricultural Society which would receive a grant.

2. Memo 2024 Budget – Street Lights, Oil City Sewers

The Clerk recommended that no levy changes be made to the Marthaville and Oil City Street light budgets. The Clerk recommended that no levy be collected in 2024 for the Howlett's lane street light.

Moved by Councillor Krall Seconded by Councillor McCallum

That the Oil City and Marthaville Street light budgets be approved with no rate increase for 2024 and that no levy be applied to the Howlett's Lane Street light in 2024.

Carried.

John Hakker was present and questioned whether the Township would take on a dusk to dawn light for a street light on Centre Street. The Clerk noted that street lights were installed at the request of a community and the costs were charged back to that community.

A discussion took place regarding the operating expenses associated with the Oil City Sewer system in 2023. It was noted that the 2024 budget estimates would see a continuing decline in the reserves for the system.

The Clerk noted that the rating bylaw approved in October of 2023 increasing the sewer rate by \$1 a month from 31.50 to 32.50.

A discussion took place regarding increasing the sewer rate for the system in 2024.

Moved by Councillor Van Dun Seconded by Councillor McCallum

That staff prepare a bylaw to increase the Oil City Sewer rate to \$37 per month.

Carried.

3. Memo 2024 AMO membership

No action was taken on the 2024 AMO membership.

4. Memo Dedicated Locator Agreement East Link

Moved by Councillor McCallum Seconded by Councillor Burke

That staff be authorized to sign the Dedicated Locator agreement for the East Link fiber optic project.

Moved by Councillor Van Dun Seconded by Councillor Krall

That staff be authorized to move forward to have design work undertaken and that tenders be authorized for the installation of a new washroom building at Krall Park.
