SECOND MEETING

MINUTES

FEBRUARY 5 2024

A meeting of the Council of the Township of Enniskillen will be held on Monday February 5 2024 at 4:30 pm at the Enniskillen Council Chambers.

Present: Kevin Marriott, Mary Lynne McCallum, Wally Van Dun, Judy Krall and Chad Burke

Mayor Marriott requested that each member of Council declare an interest at the appropriate time in the agenda where an interest may exist.

Moved by Councillor Van Dun Seconded by Councillor Krall

That the meeting moves in-camera under the provisions of the Municipal Act: Section 239 2 (c) to receive information about a proposed purchase of property and 239 2 (e) to receive information on the Ontario Land Tribunal hearing.

Moved by Councillor Van Dun Seconded by Councillor Burke

That the in-camera meeting be closed and the regular meeting be reopened. Carried.

A. Minutes

Moved by Councillor Krall

Seconded by Councillor McCallum

That the minutes of the meeting of January 15 2024 be adopted with amendment to Page 2:

Councillor McCallum declared a conflict of interest "- Brad Young request on 4th C/Johnson Creek Drain- Son is involved with improvement to the said property. Carried.

B. Interviews

1. Water- 2023 Reservoir Report

It was noted that there were no representatives from the Village of Oil Springs attending the meeting. Staff reported on the replacement of the computer and its reprogramming at the reservoir. It was noted in 2024 that the back flow on the fill station was to be replaced and funds were proposed to replace asphalt at the reservoir parking area.

Moved by Councillor Krall Seconded by Councillor Burke That the reservoir report for 2023 be accepted. Carried. Mike Cumming reported that two new pumps had been installed at the LaSalle pump station. The replacement was necessary due to wear on the existing pumps.

It was reported that water readings had completed and bills would be sent out in the current week.

2. Sewer- Verbal update

Mike Cumming noted that during a recent rain event that excess water was draining from the sanitary sewers into the pumping station. He noted that water may have entered the sanitary from farm land on the east end of Rose Street as well as water covering man holes on Oil Heritage Road.

3. Drains- Update on 4th Concession Johnson Creek Drain bridge

The Clerk reported that the property owner had submitted a request to replace the existing access to his property under Section 74 of the Drainage Act. The Clerk noted that a site meeting should be held to provide notice to the assessed property owners on the drain.

Moved by Councillor Van Dun Seconded by Councillor McCallum That a site meeting be held on the 4th Concession Johnson Creek Drain with Councillor Burke as council representative. Carried.

4. Gravel Purchase 2024

It was noted that the price for crushed limestone delivered by ship had increased by over \$3 per ton. The price had been confirmed from two abutting municipalities.

A discussion took place regarding the availability and price of other gravel that could be delivered to the Township.

Moved by Councillor Krall Seconded by Councillor Van Dun That the Township of Enniskillen purchase dolomite gravel from Johnson Bros for the 2024 year.

5. 2024 Road Projects

A review was undertaken of potential capital roads project for 2024. Projects included repairs to the Durham Creek Bridge on Black Ash Road, and the

Black Creek Bridge on Marthaville Road. This work was contingent upon engineering review of the projects.

The placement of asphalt was proposed for Shiloh Line from Marthaville Road to Fairweather Road and for Rokeby Line from Plowing Match Road to Fairweather Road. The budget included the replacement of a pickup.

Moved by Councillor Van Dun Seconded by Councillor Krall That the capital projects be approved for the 2024 budget. Carried.

A discussion took place regarding comments from Corey McKinnon about traffic speed on Oil Springs Line and the safety of his children at the school bus stop.

Information was discussed regarding the placement of stop signs at Marthaville Road, reducing the speed limit of the road to 50 km and the placement of lights on bus stop signs approaching the bus stop. Mr. McKinnon reported that the OPP were patrolling the road and was actively trying to change the drop off method for Mr. McKinnon's children.

The Clerk was requested to report back to the next meeting to determine the outcome of the work of the police.

1. Oil Springs South Enniskillen Fire Budget Information

Mayor Marriott discussed the 2024 budget for the Oil Springs Fire Department.

He noted that the total budget was anticipated to be \$187,840 of which the Township would be responsible for 78%.

It was noted that the Chief was reviewing alterations to the building to provide a clean room for the fire fighters. It was noted that a new pumper truck was planned for 2028.

Moved by Councillor Burke Seconded by Councillor Krall That the 2024 budget for the Oil Springs South Enniskillen Fire Department be approved. Carried.

2. Brooke Telecom Designated Locator

Mrs. Poland reported that the agreement would provide a work around of the dedicated locator program. It was the same agreement provided for the Cogeco and East Link fiber optic projects.

Moved by Councillor Van Dun Seconded by Councillor Krall That the Brooke Telecom dedicated locator agreement be approved. Carried.

3. Community Safety and Policing Act

Mayor Marriott noted that a discussion had been held with the Mayors of Dawn-Euphemia and Oil Springs concerning the Council representative to the police services board.

Moved by Councillor McCallum Seconded by Councillor Krall That Mayor Ian Veen be appointed as the representative to the Lambton Group Police Services Board. Carried.

The Clerk explained the location of the plan of subdivision. It was noted that additional information was to be provided regarding the truck routes for the project and about drainage affecting property in the Township.
