JUNE 16 2025

A meeting of the Council of the Township of Enniskillen was held on Monday June 16 2025 at 4:30 pm at the Enniskillen Council Chambers.

Present: Kevin Marriott, Wally Van Dun, Judy Krall, Chad Burke and Tim Williams

Mayor Marriott chaired the meeting.

Pecuniary Interest

Mayor Marriott requested that each member of Council declare an interest at the appropriate time within the agenda where an interest may exist.

A. Minutes

B. Interviews

Drainage: Kettle Lane, North Woolsey Drain Site Meeting minutes The Clerk reported that Mr. Dobbin would be present at the next meeting at which time he could discuss alternatives to address the capacity of the two drains to avoid flooding in the affected areas.

Request for Maintenance Radford-Piggott Drain

Two requests were made to have culverts repaired on the Radford-Piggott Drain. The Clerk noted that the current reports did not provide clarity regarding the sharing of costs of the culvert replacement.

Drainage Superintendent- Black Creek Drain Maintenance
The Drainage Superintendent requested that Council permit him to complete
maintenance on the Black Creek Drain on a time and material basis.

That the Drainage Superintendent proceed on a time and material basis to undertake maintenance on the Black Creek Drain.

Mayor Marriott recognized Barb Racher as the Enniskillen Township Senior of the Year for her many years on the Petrolia Enniskillen Fair Board, Lambton Cattlemen Association and as a Board Member of the Lambtonian Apartments.

Darcy Mitchell outlined work recently undertaken by public works. He noted that the dust control on gravel roads was half completed. Asphalt had been placed on Oil Springs Line and Rokeby Line. He noted that shouldering of the roads would start in the near future. Line painting would be undertaken by the County once they were in operation.

He reported that three water services were to be installed. There were additional services to be repaired and as well as a valve.

He reported that an Enbridge representative had provided a health and safety presentation to staff, regarding working around natural gas lines.

THAT While the funding provided in 2024 to offset the unexpected increases received through the annual billing statement was appreciated, there needs to be a more sustainable commitment from the province to continue to provide offsetting funding.

THAT this motion be forwarded to all municipalities in Ontario with OPP policing, AMO, the Solicitor General of Ontario Michael Kerzner, MPP Bob Bailey and Premier Doug Ford.
