The road culvert on Wanstead Road on the McMurray drain will be completed this week. Some edging will be completed on Aberfeldy Line in the near future. Repairs have been made to nine curb stops, five leaks have been repaired and two new services installed in the water system recently. There are currently three outstanding water services to install. Water operators have been exercising valves as time permits. Hydrant flushing is scheduled for late fall. The sewer system was flushed in Oil City in July.
