Petrolia North Enniskillen Fire Department – Draft Minutes of November 13 2025

Councillor Van Dun requested that the minutes be approved subject to the Township of Enniskillen requesting that the percentage share of costs for the operation of the Petrolia North Enniskillen Fire Department be lowered to 25% from 40%. Councillor Van Dun is concerned that the increased costs to operate the fire department are related to the growth in the Town of Petrolia. The Township of Enniskillen is not seeing similar growth but the costs to operate the fire department continue to increase.

Mayor Marriott confirmed that Councillor Krall did not wish to rescind the motion to approve the minutes of the meeting of November 13 2025 of the Petrolia North Enniskillen Fire Management Committee.
